Interested artists will need to submit this application packet along with a bio, and pictures of their finished pieces. Only finished pieces will be considered for the show. Packets will be reviewed by the Trend Alaska Fashion Show Committee, and final artists will be selected and notified via email by August 15. Artists will be asked to send their wearable pieces to the Trend Alaska committee by August 31.

Chosen artists will be invited to join us in Anchorage for the Trend Alaska Fashion Show September 27. To support the chosen artists' attendance, Trend Alaska will provide one roundtrip ticket on Alaska Airlines, and a one-night stay at the Aspen Hotel in Anchorage.

All applications must be submitted by June 30, 2019. Applicants may send their packets to trendakfashion@gmail.com. Only completed applications will be considered. Must be 18 or older to apply. Please note, due to the model training requirements for this show, the committee will be providing models for selected wearable pieces.
