GIGGLEFEET GUIDELINES

- The Gigglefeet Dance Committee reserves the right to exclude work that is not choreographed by Tech Rehearsal on Sunday, July 28th, for safety concerns, inadequate preparation, or if the committee deems the dance inappropriate.
- Provocative and/or challenging art, dance forms of all types are welcome.
- Gigglefeet is open to all dancers, choreographers, and tech personnel of all styles.
- While dancers of all ages are welcome, parents should be advised of mature dance styles and themes.
- Late applications, and dances by choreographers that have submitted more than 2 pieces, will be accepted only if space allows.
- In an effort to accommodate artistic expression and the audience, we will limit the number of pieces that exceed 5 minutes, and strongly suggest that longer pieces be registered as early as possible.

FIRST TIME CHOREOGRAPHERS:

- May submit only one piece.
- Pieces may not exceed 2 min. in length.
- Must attend the manditory Choreography Workshop, June 15th, 10:00 12:00 pm at KTB.
- Must meet with approved KTB teacher to show their concept, selected music, and confirmed cast.
- Dance must be reviewed by Elizabeth Shultz no later than July 11th to show outline of dance this opportunity is available to all.

PERFORMANCES:

- All dancers must perform in both both performances, Friday, August 2, and Sunday, August 4, 2019, 7:30 pm at Ketchikan High School Auditorium.
- All dancers must arrive by 7:00 pm. Order of performance will be determined by the Gigglefeet Committee to provide the most impactful experience for the audience.
- Dancers under 14 years of age can dance in a maximum of two pieces.

TRAVEL AND COSTUME GRANTS AVAILABLE:

Travel and costume grants are available on a first come, first served basis. Submit Grant applications with your Gigglefeet Dance Festival registration!

REHEARSALS:

- <u>Individual Rehearsals</u>: Studio space is available at KTB through the Gigglefeet Coordinator (Grace Jackson) and must be scheduled in advance. You are responsible for the safety and supervision of all participants in your group, including children, as this is a liability issue.
- <u>Tech Rehearsals</u>: Attendance is mandatory for all Tech Rehearsals. They will be scheduled in 30 minute intervals by the Coordinator for, Saturday, July 27 and in the morning on Sunday, July 28th. There is an added manditory tech rehearsal for all on Sunday, July 28, beginning at 4:30pm. Please direct all technical requests and questions to the Coordinator. Time restraints will be taken into consideration on a first-come, first-served basis.
- <u>Final Dress Rehearsal</u>: Attendance is mandatory for the duration of the rehearsal. Wednesday, July 31 and Thursday, August 1, at 7:00pm in the Ketchikan High School Auditorium.
